### SEASONAL GROUP CAMP CAPACITIES

Camp Crabtree	64 people - (2 units - A&B and Mess Hall)
Camp Lapihio	120 people - (4 units - Lakes/Pines/Hills/Oaks and Mess Hall)

Nightly Rates (April, May, September, October)

One Unit                    \$30 (*multiply by number of units you are reserving and number of nights you will be staying. See above capacities.*)

Mess Hall\*                \$75 (*in addition to unit cost. Multiply times number of nights.*)

(\*The Mess Hall can only be reserved if you are also reserving at least one unit of cabins. One unit of cabins is a group of 7 individual, **primitive** cabins that can hold a maximum of 27 people.)

Weekly Rates (June, July, August - Sunday to Sunday rental)

Camp Crabtree	\$375
Camp Lapihio	\$425

Weekly rates are for reserving the entire camp capacity including the Mess Hall.

### *YEAR ROUND GROUP CAMPS*

Maple Hill Lodge	\$30 per night, maximum capacity 25 people
Youth Tent Camp	\$1 per person/night, maximum capacity 25 people/minimum 9 people
